# CRIMINAL RECORD CHECK SUBMISSION PROCESS

All pharmacy student, intern, pharmacy technician, and pharmacist applicants must submit current Criminal Record, Vulnerable Sector Search, and Adult and Child Abuse Registry Checks. Please follow the steps below in order to submit your criminal record check to the College:

1. When you receive a notification via email that your criminal record check is ready, you must login to your municipality's police agency portal. Here are the links for the Province of Manitoba:

3. You will be directed to a SHARE setting page. **Focus on SECTION A only** and tick on the “YES” radio button



### Share (consent/settings)

The individual(s) you email will need to enter the required details before being able to see your completed police check (the same PDF document that you downloaded and reviewed before providing this consent).

This consent can be revoked by you at any time by selecting "No" on this screen and saving your choice.

**Instructions:**

1. Provide consent in section A;
2. Optionally - Provide enhanced security passphrase in section B; **(\*\* recommended \*\*)**
3. Submit consent;
4. Details needed by the other person will be displayed in section C after consent submitted.
