# Safety Feature: The Critical Role of Documentation and Record Keeping for Medication Incidents and Near-Miss Events

Proper documentation and record keeping are fundamental to maintaining the safety, quality, and integrity of pharmacy practice. As healthcare professionals, pharmacists are entrusted with ensuring that medication incidents are managed with precision and that continuous quality improvement (CQI) measures are effectively implemented. To meet these responsibilities, comprehensive documentation serves as both a safeguard for patients and pharmacists and is a cornerstone of regulatory compliance.

### **Why Documentation Matters**

Documentation should not be viewed as a formality but rather as a critical tool that supports pharmacy professionals in delivering safe and effective care. Whether it's tracking medication incidents or implementing improvement plans, accurate record-keeping allows pharmacies to identify patterns, reduce the risk of errors, and continuously refine processes. It also ensures transparency, allowing for accountability and regulatory review, which in turn fosters trust among patients, prescribers, and regulatory bodies.

## **Key Areas of Documentation in Continuous Quality Improvement** (CQI)

Under Manitoba's pharmacy practice standards, pharmacy managers must ensure the thorough documentation of CQI activities. This includes:

#### 1. Medication Incidents and CQI Plans

Every medication incident must be recorded, along with the corresponding CQI improvement plans. These records should be readily available for regulatory review. Documentation ensures that all incidents lead to actionable steps that enhance patient safety and reduce future risk.

#### 2. Communication with Patients and Prescribers

Beyond reporting incidents to the medication incident reporting platform, pharmacists must document all communications with the patient and prescriber involved. This serves as a record of the incident, outlining steps taken to address the issue.

### 3. Outcomes of CQI Plans from Medication Incidents

Documentation should not only reflect the creation of improvement plans but also their outcomes. By tracking the effectiveness of these plans, pharmacies can assess whether changes made after a medication incident have led to safer practices.

### 4. Outcomes from Safety Self-Assessments (SSA)

Safety self-assessments are another essential aspect of CQI, helping pharmacies to proactively identify areas of potential risk. All improvement plans developed from these assessments, along with their outcomes, must also be recorded.

### 5. Formal CQI Meetings with Pharmacy Staff

Pharmacy managers must document all formal CQI meetings, noting the date, staff present, and topics of discussion. These records demonstrate a commitment to collaborative improvement and allow for clear tracking of ongoing efforts to enhance safety and performance. Such documentation ensures that CQI remains an integral and routine aspect of pharmacy operations, rather than an afterthought.

### **Data Reports from the NIDR**

Data matters! Statistical reports from the National Incident Data
Repository (NIDR) for Community
Pharmacies highlight the common types of incidents and near-miss events in Manitoba, guiding the improvement efforts of pharmacy professionals and the College of Pharmacists of Manitoba (CPhM).

### 2023 Year in Review: Medication Incidents and Near-Miss Events

Here is a summary of the data reported by Manitoba's pharmacy professionals for 2023:

- Pharmacy professionals have submitted 2317 reports to the NIDR in 2023
- Pharmacy professionals have reported 1333 medication incidents (medication dispensed and reached the patient) and 193 caused patient harm
- Pharmacy professionals reported 984 near-miss events in 2023

### The top three incident types were:

- Incorrect dose
- Frequency
- Incorrect drug and Incorrect strength/concentration

First, I want to express my sincere gratitude to everyone who participated in the recent consultation on the Proposed Amendments to the Pharmaceutical Regulation for Pneumococcal Vaccines. Your feedback is vital in shaping the future of pharmacy practice in Manitoba, ensuring that our regulations continue to reflect the evolving needs of both healthcare professionals and patients.

The consultation process facilitated meaningful discussions with stakeholders, provided an opportunity to gather a wide range of perspectives, and helped us share important information with both registrants and the public. These efforts demonstrate CPhM's commitment to engaging actively with those who contribute to and are affected by healthcare policies. By listening to diverse viewpoints, we aim to make informed decisions that enhance the safety, accessibility, and quality of care for people living in Manitoba.

As of September 20, 2024, Manitoba's Pharmaceutical Regulations have been updated to authorize pharmacists to administer all publicly funded pneumococcal vaccines, including both existing vaccines and any that may be introduced in the future. This significant change empowers pharmacists to take an active role in the upcoming vaccine rollout, enhancing community access to these essential vaccinations.

As we prepare for this rollout, I want to emphasize that the health of our community remains our top priority. Vaccines are crucial for protecting individuals and communities from serious illnesses. We encourage everyone to stay informed about vaccination options and to encourage your patients to reach out to you for guidance.


As we navigate this busy season, I encourage you to prioritize both personal and professional growth. Whether it's exploring opportunities beyond your pharmacy scope or taking part in professional

# Stay Compliant: Ensure You Have Injection Authorization for the Fall Vaccine Season

As the fall vaccine season kicks off, pharmacists and pharmacy managers must ensure they comply with Manitoba's Pharmaceutical Regulation by practicing within their authorized scope. Administering drugs and vaccines by injection is considered an expanded scope activity, and proper authorization from the College of Pharmacists of Manitoba (CPhM) is required.

### **Key Reminders:**

### Practice within your authorized scope:

 Pharmacists must practice within their authorized scope of practice. Administering drugs and vaccines by injection requires specific authorization from the CPhM after you've completed the necessary training.

### Training Does Not Equal Authorization:

 Completing educational requirements alone does not grant you the authority to administer injections. You must apply for and receive formal approval from CPhM.

### **Requirements for Authorization:**

- Hold a valid pharmacist license and remain licensed with CPhM
- Complete the required injection training
- Maintain current CPR and First Aid certification
- Submit an application for injection authorization and receive approval from CPhM

### Transitioning from Intern to Pharmacist:

 If you were authorized by CPhM to administer injections as an intern, that authorization does not transfer to your pharmacist license. You must apply for injection authorization once you are granted a licence to practice and declare you have met and maintained the requirements annually upon license renewal.

### Follow-Up on Applications:

 It is your professional responsibility to follow up with CPhM after submitting your application to confirm that it was received and approved. You cannot provide injections until you have received notification from CPhM that your application was approved.

#### Review and Confirm Authorization:

- Pharmacists should regularly review their profiles to ensure accuracy and confirm their injection authorization status.
- Pharmacy managers should verify that all staff pharmacists are properly authorized before providing injections.

Pharmacists who administer injections without proper authorization will be referred to Complaints. To avoid disruptions in your ability to provide essential vaccinations this fall, ensure that all requirements are met, your application is submitted, and your authorization is confirmed.
