# The Nova Scotia Experience

The Pharmacy Association of Nova Scotia (PANS) has piloted the implementation of community pharmacy primary care clinics (CPPCC). Forty-six pharmacies across Nova Scotia are operating these pharmacy clinics whereby pharmacists have a dedicated time and space to provide appointment-based services, working to their full scope of practice to provide effective care for patients. A demonstration project was funded by the Department of Health and a final evaluation has been conducted by an independent research firm. This presentation will include a summary of the implementation process, the findings of the evaluation including successes and lessons learned as well as a first hand account of the experience from a pharmacist working front line in the clinic.

With the Manitoba Prescription Birth Control Program providing coverage for prescription contraceptives to eligible Manitobans, the role of the pharmacist in ensuring their safe and effective use is more important than ever. The evolving scope of pharmacists in many provinces is an opportunity for those on the front lines to utilize their training to help patients improve access to sexual and reproductive health services, including contraception. In this session, Dr. Omolayo Famuyide will discuss some of the recent updates in contraception, important considerations when it comes to patient assessment, contraceptive selection, and monitoring.

- Review the importance of patient choice and patient satisfaction for HCPs who
  provide contraceptive counselling
- Address principles of effective contraceptive counselling in supporting patients' decision making about contraceptive methods

- Review provider considerations in counselling on contraception, specifically longacting reversible contraceptives (LARCs)

Her passion for women's health led to the completion of a twelve-month fellowship at the University of Toronto, a world leading institution in women's health. A Certified Menopause Practitioner through The Menopause Society (formerly the North American Menopause Society), Dr. Famuyide's proficiency in the areas of reproductive health, advanced contraception and menopause is well regarded. Dr. Famuyide is a known expert in the areas of contraception and menopause, having been invited to speak on these topics to various medical trainees, practitioners and other allied health professionals.

Beyond her role as a clinician, Dr. Famuyide is an educator, and an advocate for women's health. Most recently, she was honored to be selected as a recipient of Canada's Top 100 Black Women to Watch of 2024!

# **Workplace Safety**



## 2:15 pm

This presentation is designed to give employees and employers a better perspective on the rights and responsibilities they have regarding violence in the workplace.

We will discuss: types of workplace violence, how to respond to a violent confrontation in the workplace, and offsite workplace safety considerations. All employees and employers play an important role for creating a safe work environment

Part 11 of Manitoba Workplace Safety and Health Regulation, (M.R. 217/2006,) requires employers to identify and assess the risk of violence in the workplace in consultation with the workplace safety and health committee or representative. If there is no committee or representative, the employees at the workplace should be consulted.

When a risk of violence in the workplace is identified, an employer must:

- 1. develop and implement a violence prevention policy in consultation with the workplace safety and health committee, representative, or employees
- 2. train employees in the violence prevention policy
- 3. ensure that employees comply with the policy

### **Learning Objectives**

- Will be able to identify and assess the risk of violence in the work place as required by Part 11 of the Manitoba Safety and Health Regulation (MR 217/2006)
- Workers will be able to take measures to prevent the occurrence of violence and have recourse should they be subjected to it
- Will understand what the meaning of "workplace violence" as per the Manitoba Workplace Health and Safety's interpretation
- Will be able to define the Criminal Code of Canada's offences: Assault and Assault with Weapon
- Will recognize the 4 types of violence in the workplace and how to keep themselves safe when confronted by an aggressive individual
- Recognize best safety practices when working off site

# Sunday, March 23rd Grey Matters: Decision Making in Pharmacy Practice



## 9:30 am

Pharmacists are presented with challenging decisions every day. In the setting of increased workload demands, expanded scope of practice, and limited resources, it is crucial to understand how we make decisions. This session will explore what "grey areas" mean in pharmacy practice, how cognitive biases affect our decision making, and different decisionmaking frameworks to consider when faced with complex problems.

### **Learning Objectives**

- Recognize Cognitive Biases: Identify cognitive biases that can affect decision making in pharmacy practice
- Understand Problem-Solving Frameworks: Describe key problem-solving frameworks and strategies that pharmacists can use to address common challenges in practice.
- Apply Critical Thinking in Pharmacy: Demonstrate how to apply critical thinking skills to evaluate patient cases and identify appropriate solutions in pharmacy practice.
- Enhance Decision-Making Skills: Develop decision-making skills that balance clinical evidence, patient preferences, and professional judgment in the face of complex problems.

# Dysphoric about Dyslipidemia? It's time to simplify

### **Learning Objectives**

- 1. Apply best evidence of benefit and harm using patient-specific information to guide decisions on use of lipid-lowering therapy and recommend the most appropriate agent and dose.

# Laurie Zawertailo

PhD, Senior Scientist, Institute for Mental Health Policy Research, INTREPID Lab (formerly Nicotine Dependence Services), CAMH.
Associate Professor, Department of Pharmacology and Toxicology, University of Toronto.

Dr. Zawertailo's lab focuses on increasing our understanding of nicotine and tobacco addiction (including e-cigarettes) and exploring novel approaches to treatment, especially for specific populations such as young adults, women, and people with co-occurring depression or alcohol use disorder and has over 110 peer-reviewed publications. Her current research is supported by: 1) CAMH womenmind to identify the role of menstrual cycle phase on tobacco and e-cigarette craving and cue-reactivity; 2) Canadian Institute of Health Research (CIHR) to examine the effectiveness of transcranial direct current stimulation as an adjunct to varenicline treatment for smoking cessation; 3) Canadian Cancer Society (CCS) to determine the effectiveness of timing quit date to menstrual cycle phase to improve smoking cessation outcomes in women, and: 4) Health Canada – Substance Use and Addiction Program (SUAP) to explore harm reduction and cessation using e-cigarettes or cytisine in treatment-resistant smokers.
