### **IMPORTANT REMINDERS:**

1. Fees are due upon receipt of invoice and are non-refundable.
2. Renewal fees are due November 15 and effective January 1 to December 31 of the upcoming Practice Year.
3. Registrants who stop practicing for a period of time during a practice year are not entitled to any reduction in their annual fees.
4. A Conversion Processing Fee will be charged for any change of registration class made outside the annual renewal period.
